EXHIBITOR GENERAL TERMS AND CONDITIONS

The Exhibitor General Terms and Conditions shall apply equally to all exhibitors of Crofish – 15th International Fisheries Fair.

1. *The Organiser of the fair is the Association of Craftsmen of Istria County (hereinafter: OKIŽ).*
2. *The Technical Performer of the fair is the company Studio 053 d.o.o. from Poreč.*
3. *All natural and legal persons having filled in, certified and submitted the Registration Documentation on time are entitled to take part in the Crofish fair provided that they comply with the obligations set out in the Exhibitor General Terms and Conditions, which entitles them to the title of Exhibitor. The Registration Documentation comprises the Registration Form, Appendix, and Exhibitor General Terms and Conditions. Details of the Exhibitors' participation in the Fair are determined in the Registration Documentation. A Registration Form, filled out, certified and signed by the Exhibitor and delivered to the Technical Performer – the company Studio 053 d.o.o. is considered a concluded written contract. The deadline for submitting the Registration Documentation is 3rd November 2023.*
4. *The Exhibitor shall comply with all applicable laws and regulations relating to the company's operations and participation in the Fair and shall bear sole responsibility and consequences for failure to do so. Under the term "Exhibitor", the Organiser shall also consider all persons working under the instruction of the Exhibitor.*
5. *Studio 053 shall allocate exhibition space on the basis of submitted Registration Forms. If needed, Studio 053 reserves the right to allocate an area to the Exhibitor up to 10% larger or smaller than requested in the Registration Form. Should circumstances beyond their control occur, Studio 053 has the right to withdraw the allocated space and assign an alternate exhibition space if that is in the interest of the Fair, which shall not entitle the Exhibitor to cancel his participation, request changes and/or claim compensation for damages. The Organiser shall hand over the stand and ordered equipment to the Exhibitor at the latest 24 hours before the official opening of the Fair; any complaints shall be submitted in writing no later than 12 hours prior to the start of the Fair. The Exhibitor shall allow unobstructed passage through his stand of any installations necessary for equipping, technically or by other means, the exhibition space or another exhibitor's stand.*
6. *Upon receiving the Registration Documentation, OKIŽ shall send the invoice for the exhibition fee. Invoice/s for any other additional items and services ordered (not included in the exhibition space) shall be sent by the Contractor.*
7. *Upon the closing of the Fair, Studio 053 shall issue the final calculation to the Exhibitor for all the services ordered and rendered, which shall be invoiced by the Contractor.*
8. *Prices are expressed in euros and do not include VAT. Prices are converted from euros into Croatian kuna according to the fixed conversion rate €1 = HRK 7.53450. Payment shall be made according to the quote/invoice.*
9. *Exhibition space at the Crofish fair shall be considered secured by the Exhibitor solely upon the timely payment of the invoices. If the Exhibitor fails to pay the specified amount by the due date, and not later than 10 days prior to the start of the event, OKIŽ and Studio 053 are entitled to cancel the confirmed exhibition space and Registration Form. Late payments shall be charged penalty interest.*
10. *Technical specifications and terms of use:*
 - a) *The stand is constructed from Octanorm, 250 cm in height, with posts at every 100 or 50 cm.*
 - b) *Upon request, the Organiser shall provide the exact measurements for the production of vinyls and the better planning of merchandise placement.*
 - c) *The Organiser shall lay a carpet in the Fair's colour scheme inside at all equipped stands.*
 - d) *Drainage and water supply are possible only at the marked positions on the floor plan of the exhibition space. The Exhibitor shall submit a layout of the exhibition space with the marked positions of electrical and plumbing needs in advance. The Organiser shall install a power socket, water supply and drainage at the stand at the most technically suitable location, whereas the running of cables and pipes at the stand and connecting them to the equipment is the obligation of the Exhibitor (the Organiser is not obliged to provide staff or any required tools and equipment).*
 - e) *Graphics may be applied to the panels solely using "Easy Dot" vinyl and only with prior notice to the Organiser; at the end of the Fair, the Exhibitor shall remove the vinyl and return the stand in its original state.*
 - f) *If ordering additional equipment, please provide a sketch of how you would like it positioned at the stand.*
 - g) *Changes to the stand, which are not predefined and submitted in the layout, and additional equipment orders at the Fair may only be done with the Organiser's consent. If the requested equipment is available, the prices quoted in the additional equipment price list from the Registration Documents shall be increased by 100%.*
11. *The Exhibitor shall not offer or sublet the exhibition space to a third party without the Organiser's permission. The Exhibitor shall end all works on setting up the stand 12 hours before the start of the Fair and all arranging of the exhibits 4 hours before the start of the Fair.*

EXHIBITOR GENERAL TERMS AND CONDITIONS

12. *The Organiser shall publish a Fair Catalogue in which all the exhibitors registered no later than the stated deadline (3rd November 2023) shall be presented. The Exhibitor shall provide a publish-ready advertisement by e-mail no later than the application deadline. If the Exhibitor fails to deliver it on time, the Organiser shall not be able to publish it. The Exhibitor shall be fully responsible for the data entered in the catalogue, for the content of the advertisement, and for any damages caused by submitting unsuitable content; the Organiser shall not be liable for any inaccuracies in the catalogue.*
13. ***Exhibitors may not remove exhibits from the exhibition area before the closing of the Fair. Working hours of the fair shall be: Friday, 24/11/2023, from 12:00 to 19:00; Saturday, 25/11/2023, from 10:00 to 19:00; Sunday, 26/11/2023, from 10:00 to 19:00. Exhibitors who begin to pack away the stand before the end of visiting hours shall be charged a fee of €665.***
14. *The Organiser shall assume responsibility for the safety and security of the Fair grounds and shall employ a 24-hour security service during the Fair. The safety of the exhibits at the stand shall be the Exhibitor's responsibility. The Organiser and Technical Performer of the fair shall not be liable for any damage, loss or theft of the Exhibitor's property. Furthermore, they shall not be held responsible for the disappearance of any items from the stand during the visiting hours of the Fair. After the closing of the fair, on Sunday, 26/11/2022, from 19:00h onwards, the Exhibitor shall assume all responsibility for its exhibits.*
15. *The Registration is irrevocable and binding, and any cancellation thereof shall be made in writing. If the Exhibitor cancels his participation in the Fair no later than 15 days prior to the beginning of the Fair, 50% of the contracted value of the exhibition space shall be invoiced nonetheless. For cancellations of participation in the Fair made within 15 days or less prior to the beginning of the Fair, the full amount for the ordered exhibition space shall be invoiced.*
16. *The Organiser shall be responsible for the cleaning of the fair grounds and hallways; the Exhibitor shall be responsible for the cleaning of their exhibition space.*
17. *Any dispute between the Exhibitor and the Organiser shall be settled by mutual agreement; if they fail to reach an agreement, the parties hereby agree to the jurisdiction of the Court in Poreč.*
